

Motion 1: Real Estate Transaction Authority

The House of Delegates authorizes the Board of Directors to sell the existing headquarters building at 520 N. Northwest Highway, Park Ridge, Illinois, and to lease alternative office space to meet the needs of ASSP operations

Motion 2: Governance Change (Dissolving the House of Delegates Position)

The House of Delegates approves the revised ASSP bylaws, ASSP Revised Bylaws January 28, 2022, enacting the governance changes approved by the Board of Directors.
