Membership Meetings Recap

March: Occupational and Social Safety for People with Disabilities with Ian Jaquiss, JD



Following a traumatic spinal cord injury as a toddler, lan has had to learn how to navigate a world not built for people who use wheels to get around. His tenacity led him to represent the United States at the 1984 and 1988 Paralympic Games, winning four medals, including two golds at the Seoul games in 1988. In his talk, lan shared his expert insights on creating inclusive and welcoming climates and cultures, in both work and social settings, for all people but especially people with disabilities. In our candid conversation with lan at the March member meeting, we learned the role safety professionals play in issues related to disability access, equity, justice, and opportunity.

April: Drugs of Abuse with Annie Duncan, BSN, RN, CEN, CSPI



For our annual joint meeting with Oregon State Association of Occupational Health Nurses (OSAOHN), Annie Duncan, Nurse Manager of the Oregon Poison Center, shared an update on the types of drugs causing the most serious problems in our area today, and those emerging on the horizon. We learned how to recognize the drug's effects and "overdose" risk, how to recognize the most common signs of overdose, and apply appropriate first aid or rescue treatments that may be available.

May: Unlocking Workplace Safety: bold strategies and collaborative innovations with:


Nick Cordell (Safety Director, Mortenson), Maggie Creps Weaver (HR Director Medical Teams International), Everett Runyan (Total Worker Health Coordinator Oregon Dept of Human Services) and Paul Wallman (Facilities Manager World Trade Center)



In this dynamic panel discussion, we learned from experts from diverse fields to explore the strategies, collaborative approaches, and innovative technologies shaping the future of workplace safety. From Mortenson's consistent engagement of front-line employees in fostering a culture of safety to Medical Teams International's dedication to duty of care for employees working in environments plagued with armed conflict and disease, we explored the foundational values and policies essential to worker safety and well-being. Everett Runyan described the challenges and opportunities in supporting a diverse workforce spread across urban and rural environments and his recommendations for implementing meaningful interventions and strategies and evaluating outcomes. Paul Wallman demonstrated his skills in managing conflict and compassionate communication for bringing stakeholders together to align values and resources for workforce safety.

Spring PDC Recap

On May 13th the chapter hosted a **virtual workshop**, **Ethics for the Safety Professional – from Research to Practice**, led by Dr. Daniel Snyder. We had **27 attendees** and were able to provide **0.2 CEUs in ethics** for those with BCSP certifications. Dr. Snyder provided this workshop at no cost, allowing ASSP and non-ASSP members to obtain these CEUs in ethics at a very low cost.
