Federal OSHA – Adopted Rule Stage

- Hazard Communication Update:
 - Harmonize the HCS to the latest edition of the Globally Harmonized System of Classification and Labeling of Chemicals (GHS), and
 - Codify enforcement policies OSHA has issued since the 2012 standard.
 - Rule adopted May 20, 2024
- Worker Walkaround Rule:
 - OSHA updated employee representative procedures for inspections.
 - Codify policy from Sallman Letter
 - Rule adopted April 1, 2024 Under litigation
- COVID-19 in Healthcare Setting:
 - OSHA continues to work expeditiously to issue a final standard that will protect workers from COVID-19.
 - Final Rule expected in December 2024

Federal OSHA – Pre-rule Stage & Long-Term Actions

- Pre-Rule:
 - Blood Lead Level for Medical Removal

- Long-Term Actions:
 - Injury and Illness Recordkeeping
 - Mechanical Power Presses
 - Powered Industrial Trucks
 - Silica in Construction Table 1
 - COVID-19 Vaccination and Testing Emergency Temporary Standard

Oregon OSHA – Adopted

- Federal and Oregon OSHA Minor Corrections
 - No substantive change
 - Divisions 1, 2, 3, and 4
 - Affects 19 rules with approximately 60 minor corrections
 - Adopted September 11, 2024, and effective September 11, 2024

Oregon OSHA Proposal Rulemaking

- Employer-provided housing (ALH)
 - Proposed on 9/6/24
 - Comment period closes on 11/3/24
 - Public Hearings:
 - 10/17/2024 at 1:00 pm
 - 10/17/2024 at 6:00 pm
 - 10/18/2024 at 11:00 pm Spanish
 - 10/21/2024 at 6:00 pm Spanish
 - 10/25/2024 at 10:00 am
