

## **ASSP Columbia-Willamette Chapter Membership Dues Grant**

The purpose of this fund is to provide continuing education aid to deserving members who are currently experiencing hardship due to the COVID-19 Pandemic Crisis and are actively seeking or employed in a job role which entails occupational safety, health and/or environmental science (SHE). Applicants who meet this criteria will be considered for 1 year of paid membership from the CWC Chapter.

### **Eligibility Requirements**

1. Candidates must be actively seeking employment (i.e. even outside of SHE) or working in the SHE field in the local Portland-Metro Area.
2. Candidates must be an active member of the CWC Chapter or one of the local sections of the CWC ASSP Chapter.

### **Selection Criteria**

1. A demonstrated interest in pursuing continuous education via ASSP in the field of occupational safety, health and/or environmental science.
2. Participation in the ASSP CWC chapter or connected sections.
3. Financial need due to lack of employer support or loss of current job role.
4. Short answer question completed and returned with application.
